It is **HEREBY AGREED** that the owner shall let on hire to the hirer, academic costumes comprising of a **gown**, **hood** and **a cap** and the hirer shall take the said academic costumes on the following terms and conditions:

- 1. The hirer shall pay the owner hire charges of **Tsh. 45,000/=** for the said costumes.
- The hirer shall during the period of hire and at his/her own expense keep the said costumes in good condition and shall be responsible for all risks of loss or damage to the said costumes.
- 3. The hirer shall return the said costumes to the owner immediately after the graduation ceremony and in any case **NOT LATER THAN SEVEN WORKING DAYS** after the date of the graduation ceremony.
- 4. Penalty of Tsh. 10,000/= shall be charged for each day of default to return the hired costumes and in the event of loss of the costume the owner shall be entitled to recover such loss at the current replacement cost of a new costume from the hirer.
- 5. A defaulting hirer **SHALL NOT BE ISSUED** with either a degree certificate or academic transcript unless and until either the costume is returned or full replacement cost of a new costume is paid and only after discharge the full penalty due under paragraph 4 above.
