1. This request for Expression of Interests follows the General Procurement Notice for this Project that appeared in United Nations Development Business (UNDB) Issue No. **WB-OP0015674** of **28.11.2021**.
2. The Government of the United Republic of Tanzania through the Ministry of Education Science and Technology (MoEST) has received financing from the World Bank toward the cost of the **Higher Education for Economic Transformation Project (HEET)** in Tanzania, and intends to apply part of the proceeds for consulting services.
3. The consulting services ("the Services") include carrying out Environmental and Social Impact Assessment for the Construction Sites of the University of Dar es Salaam – **Dar es Salaam Campuses Lot** (Mwalimu Julius Nyerere Mlimani

campus, Kijitonyama Campus, Kunduchi Campus), and **Out of Dar es Salaam Campuses Lot** (Ngongo sites in Lindi; Likunja site in Ruangwa; and Buyu site in Zanzibar). The total duration for the entire assignment shall be 3 months.

4. The detailed Terms of reference (TOR) for the assignment are available in the following website www.taneps.go.tz and www.udsm.ac.tz or can be obtained at the address given below. **Please note changes to Sections 3.0, 4.0, 5.0, 9.1 and 9.3 of the updated ToRs.**
5. The University of Dar es Salaam now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:
 - A. **Core business and ten (10) years in business**
 - B. **Relevant similar experience, which should specifically include the following;**
 - 1) A firm registered with NEMC as an Environmental expert and should have at least 10 years experience in conducting EIA/EA /ESIA studies.
 - 2) The firm must have undertaken at least three (3) Environmental and Social Impact Assessment assignments in the last ten (10) cumulative years.
 - 3) Experience in design and environmental systems construction and installation.
 - 4) At least three (3) projects of similar nature were executed by the firm within the previous ten (10) years.
 - C. **Technical and Managerial Capability of the Firm**

The Consultant must provide the structure of the organization, general qualifications and number of Key staff for each assignment expressed interest. (Do not provide CV of the Key staff). Key Experts will not be evaluated at the shortlisting stage).
6. The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" Fourth Edition, November 2020 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.
7. Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the

partners in the joint venture shall be jointly and severally liable for the entire contract, if selected. Therefore, each member of JV shall independently meet the requirements of the evaluation criteria. The experience, technical & managerial capability of the Sub-Consultant shall not be evaluated to enhance the qualification of the Lead Firm or JV.

8. A Consultant will be selected in accordance with the **Consultant's Qualification Selection (CQS) method** set out in the Procurement Regulations.
